## ARE YOU LEAVING YOUR SPANISH ESTATE TO YOUR CHILDREN?

Above fees are per beneficiary and include IVA, notary and solicitors fees (and for UK notaries - every page of passports and other ID documents all being individually notarised)

By doing this while you are alive the whole probate process will then be simple, quick and painless for your children after you have gone. In addition, your children won't be left having to each find what could well be considerably more than this amount in the future before they can actually inherit what you have left them.

You should also ensure you have arranged a Prepaid Funeral Plan in advance - see the reverse of this leaflet if you have not yet done this.
